Would Harris County be authorized to pay for or otherwise provide a defense to a member of the CJCC against whom a lawsuit were filed or otherwise pay a judgment for an individual member of the CJCC sued for an action taken by the CJCC? If an independently elected official acts contrary to standards adopted by the CJCC would this open up the County or the official to liability? What code of ethics, state or local, apply to members? Who will write the language of the Commissioners Court posting of the CJCC meeting?
