

SUPPLEMENTAL NOTICE OF A PUBLIC MEETING

Notice is hereby given that, prior to the adjournment of the regular meeting of Commissioners Court on **Tuesday, April 7, 2020**, the Court will consider the following supplemental agenda items.

7. Transmittal of notice by the Purchasing Agent of an agreement with United Health Partners, Inc., dba UHPHealth, in the amount of \$712,065 for set-up, management and staffing of a designated Homeless Medical Isolation and Recovery Shelter in connection with the disaster declaration for COVID-19 for the period of April 1-June 30, 2020 with three one-month renewal options.

Request by the Purchasing Agent for approval of an award to various vendors on the basis of best bids in the estimated amount of \$800,000 based on estimated quantities and fixed pricing for temporary staffing for Harris County for the term of April 7, 2020 through March 30, 2021, with four one-year renewal options (190296).

Request by the Purchasing Agent for approval of a Public Health or Safety Exemption from the competitive bid requirements for Garner Environmental Services, Inc., in the estimated amount of \$60,000,000 for Non-Congregate Medical Shelter (NCMS) for Harris County, and that the County Judge execute the agreement.

Request by the Commissioner of Precinct One for discussion and possible action regarding the Community Services Department's Emergency Rental and Utility Assistance programs in the context of the impact of Coronavirus disease and the passage of the Coronavirus Aid, Relief, and Economic Security Act.

Request by the Commissioner of Precinct 4 for an executive session to discuss the purchase of real property in the Elm Grove area needed for flood control purposes.

V. Appearances before court

The Clerk of the Court or another person designated by the presiding member of the court shall keep the time for speakers. Those persons who do not conduct themselves in an orderly and appropriate manner will be ordered to leave the meeting and recognition to speak may be refused at subsequent meetings of the court. Refusal to abide by the court's order may result in a Contempt of Court Citation.

1. 3 minutes

A speaker whose subject matter as submitted relates to an identifiable item of business on this agenda will be requested to come to the podium where they will be limited to three minutes. A speaker whose subject matter as submitted does not relate to an identifiable item of business on this agenda will be limited to three minutes if they have not appeared at any of the three preceding court meetings on the same issue.

2. 1 minute

A speaker whose subject matter as submitted does not relate to an identifiable item of business on this agenda and who has appeared at any of the three preceding court meetings on the same issue will be limited to one minute.




