ORDER OF COMMISSIONERS COURT
To Extend the Declaration of Local Disaster for Public Health Emergency

The Commissioners Court of Harris County, Texas, convened at a meeting of the Court, virtually, on June 09, 2020 with all members present except none.

A quorum was present. Among other business, the following was transacted:

**EXTENSION TO JULY 1, 2020, OF THE DECLARATION OF LOCAL DISASTER

Whereas, on March 11, 2020, a Declaration of Local Disaster for Public Health Emergency was issued to allow Harris County to take measures to reduce the possibility of exposure to COVID-19 and promote the health and safety of Harris County residents; and

Whereas, on March 17, 2020, the Declaration of Local Disaster for Public Health Emergency was extended to March 25, 2020; and

Whereas, on March 24, 2020, the Declaration of Local Disaster for Public Health Emergency was extended to April 29, 2020; and

Whereas, on April 28, the Declaration of Local Disaster for Public Health Emergency was extended to May 20, 2020;

Whereas, on May 19, the Declaration of Local Disaster for Public Health Emergency was extended to June 10, 2020;

Now, therefore—

IT IS ORDERED that:

1. The Declaration of Local Disaster for Public Health Emergency Declared by County Judge Lina Hidalgo and signed on March 11, 2020 shall be and is hereby further extended to July 1, 2020.

2. All Harris County officials and employees are authorized to do any and all things necessary or convenient to accomplish the purpose of this Order.
